World Breastfeeding Week was celebrated in the month of August with the theme of "Protect Breastfeeding is a Shared Responsibility". SASPEN supports the role that breastfeeding and expressed breastmilk play in paediatric clinical nutrition. We advocate the importance of breastmilk as a first choice, even in the context of enteral route feeding and the preferred choice of nutrition, when weaning off from parenteral nutrition in infants. In addition, SASPEN's role and responsibility to support, protect and promote breastfeeding is to strive to align its practices and recommendations within the guidelines of the R991 Regulation Relating to Foodstuff for Infants and Young Children.
